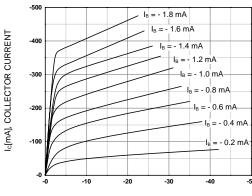

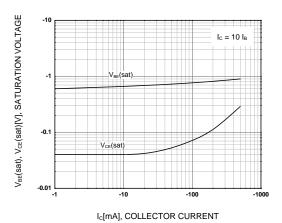

V<sub>CE</sub>[V], COLLECTOR-EMITTER VOLTAGE







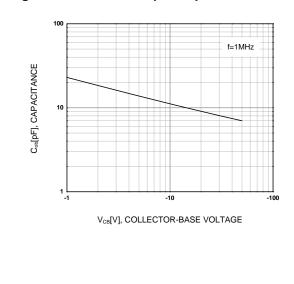


Figure 2. DC Current Gain

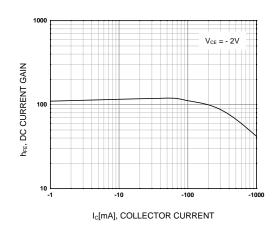
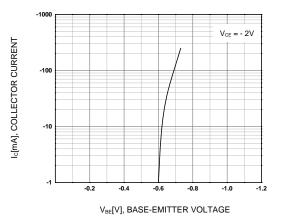
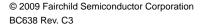
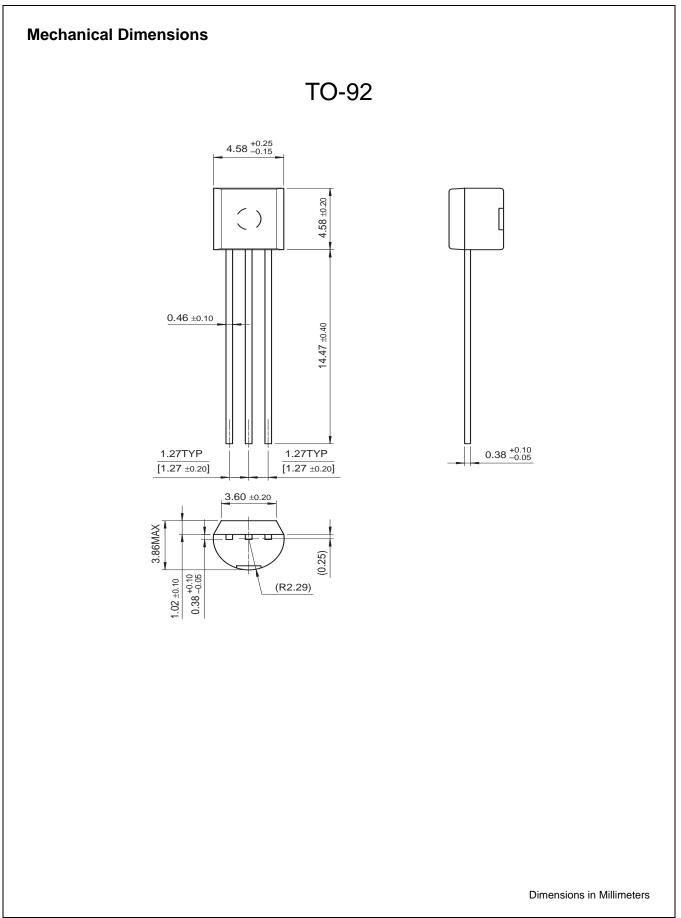


Figure 4. Base-Emitter On Voltage
