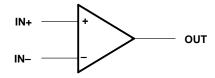
## description

The RC4136, RM4136, and RV4136 are quad general-purpose operational amplifiers, with each amplifier electrically similar to the  $\mu$ A741, except that offset null capability is not provided.

The high common-mode input voltage range and the absence of latch-up make these amplifiers ideal for voltage-follower applications. The devices are short-circuit protected and the internal frequency compensation ensures stability without external components.

The RC4136 is characterized for operation from  $0^{\circ}$ C to  $70^{\circ}$ C, the RM4136 is characterized for operation over the full military temperature range of  $-55^{\circ}$ C to  $125^{\circ}$ C, and the RV4136 is characterized for operation from  $-40^{\circ}$ C to  $85^{\circ}$ C.

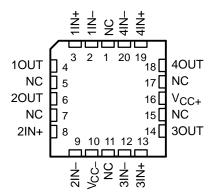

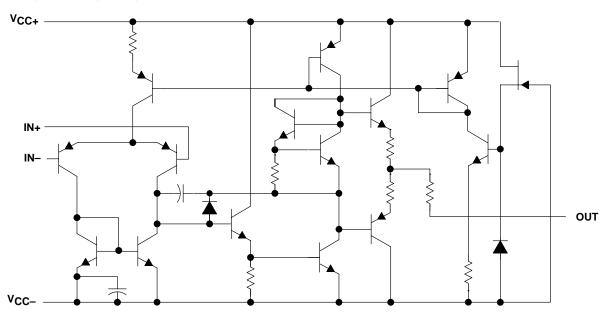
